## Welcome Message

With the guidance of the Financial Supervisory Commission (FSC), Taiwan Financial Services Roundtable (TFSR) established the Financial Technology Development Fund in 2016. Over the past two years, the Fund has been diligently engaged in the integration of diversified resources, as well as the facilitation of important tasks including Taiwan FinTech Development, Accelerator Programme, Talent Cultivation and International Connection. The birth of FinTechBase marks the first FinTech accelerator in the country with the collaborative incubation of the government, the industries and the research sectors. FinTechBase is established to provide a systematic training and education for FinTech talents. In addition to fundamental training for university/college students, it also helps building up the cross-disciplinary expertise for financial professionals and mid/senior managers in the FinTech industry. By cooperating with major local and overseas innovation accelerators and incubation centers, mentoring services are provided by FinTechBase to fintech startup, too. With regard to it, there are 49 FinTech startups in total have received the service since 2016.

To effectively sharpen the competitive in FinTech innovation, TFSR has, with the support of the FSC, further facilitated the materialization of the virtual innovation bases since this year. FinTechSpace, the first hub for FinTech innovation in Taiwan, has launched in September 2018. FinTechSpace provides one-stop-shop services, resources and the environment for innovative FinTech development, including Startup Acceleration and Incubation, Enterprise Laboratories, Digital Sandbox for innovation ideas POC (Proof-of-Concepts), Regulatory Mentoring, Regulatory Clinic, and Global Connection. Through successful international connection, FinTechSpace builds up a bridge between Taiwan's FinTech industry and the international market, and contributes to increasing the competitiveness of the industry.

Following the establishment of FinTechBase and FinTechSpace, "FinTech Taipei 2018" is the third major contribution organized by TFSR. FinTech Taipei is also included as a key project of the "Action Plan for Financial Development" announced by the Executive Yuan. FinTech Taipei 2018 is believed to bring in fresh momentum to the FinTech startups in Taiwan, facilitate exchanging and cooperation among both local and international FinTech players, and stimulate new business opportunities. The FinTech Taipei 2018 is expected to be the pioneer of many important international FinTech events in coming years, showcasing Taiwan's FinTech strengths to the world.
