## About FinTech Taipei

An increasing number of discussions on FinTech have been taking place in recent years. Thriving developments in various technical applications, and innovative integration of the financial and technology sectors all make financial services more efficient. Promoting FinTech in Taiwan, incubating potential companies in FinTech, and cultivating FinTech talents, will make the Taiwan financial sector more competitive. Supervised by the Financial Supervisory Commission (FSC), the Taiwan Financial Services Roundtable (TFSR) established the “FinTech Development Fund”, and the Fund was donated by 11 organizations: Bankers Association of the Republic of China (BAROC), Taiwan Securities Association(TSa), Life Insurance Association of the Republic of China(LIA-ROC), Non-Life Insurance Association of the Republic of China(NLIA-ROC), Taiwan Stock Exchange Corporation (TWSE), Taipei Exchange (TPEX), Taiwan Futures Exchange (TAIFEX), Taiwan Depository & Clearing Corporation (TDCC), Financial Information System Group (FISG), Joint Credit Information Center (JCIC), and National Credit Card Center.(NCCC). It is the first public-interest fund that Taiwan focused on the development of FinTech and gathered resources from the financial sector. It is expected to highlight an overall national financial innovative energy by cross-sector integration, to achieve the economies of scale, and to accelerate the innovation in financial industries.

Supervised by the Financial Supervisory Commission (FSC), FinTech Taipei is an annual major event supported by the FinTech Development Fund, and it is one of the major strategies in the Action Plan for Financial Development of the Executive Yuan. The Taiwan Financial Services RoundTable (TFSR) and Taiwan Academy of Banking and Finance (TABF) co-hosted the event. Channeling FinTech resources from domestic and international financial and technology sectors, officials, universities and researches, combining themes like RegTech, AI, blockchain, VR, and big data, and by way of feeling, experiencing, and sharing to connect all the features, FinTech Taipei provides an opportunity for domestic and international financial and technology industries, as well as the public, to collaborate and to interact with each other. It is hoped that FinTech Taipei will establish a Taiwan standard financial and technology platform, and witness the development potential of Taiwan FinTech.

## Welcome Message

In response to the global fintech development and to motivate innovations from the financial industry, the Financial Supervisory Commission (FSC) has dedicated to build a fintech-friendly environment. To achieve such goal, the FSC not only implemented the Financial Technology Development and Innovative Experimentation Act, but also setup a “FinTechSpace” in 2018. The FinTechSpace is the first fintech-focused co-working space in Taiwan, and a tech-based environment for accelerating the latest fintech innovations and cultivating talents.

The investment in fintech development by the local financial industry amounted to NT\$ 11.73 billion in 2018 and is expected to reach NT\$ 21.93 billion in 2019; with an annual growth rate of 86.9%. To enhance the efficiency and convenience of financial services, the FSC has further extended the scope for fintech applications in 2019. Milestones include the approvals granted for three internet-only banks in July, formation of open banking implementation programme and development of preliminary framework for Security Token Offering (STO). Furthermore, a convergence of the Act Governing Electronic Payment Institutions and the Act Governing the Issuance of Electronic Stored Value Cards was made possible to enable a more interoperable fintech environment. In addition, subsequent to the signing of the fintech cooperation agreements with the Polish Financial Supervision Authority (KNF) and the Arizona Attorney General's Office in the US in 2018, the FSC signed a fintech cooperation agreement with the French Autorité de Contrôle Prudentiel et de Résolution (ACPR) in 2019. To boot, the FSC joined the Global Financial Innovative Network (GFiN) this May and is participating in the Network's Cross-border testing and RegTech workstreams.

FinTech Taipei Expo has earned a great success last year and we aim to sustain the magnificence with a bigger scale as well as cross-border participation. It will showcase more fintech innovations, talents and business opportunities. I wish you all the success and welcome to FinTech Taipei 2019!

## Welcome Message

Supervised by the Financial Supervisory Committee (FSC), Taiwan Financial Services Roundtable (TFSR) established the FinTech Development Fund in 2016. It was the first public-interest fund focused on FinTech development supported by the financial sector in Taiwan. With this Fund, TFSR has been able to assist the FinTech development in three key areas: cultivating FinTech talents, building a financial technology innovation park, and holding FinTech exhibitions. Among them, holding FinTech exhibitions has been listed in the Action Plan for Financial Development of the Executed Yuan, and the annual action plan of the FSC.

In 2018, TFSR and Taiwan Academy of Banking and Finance (TABF) co-hosted the first FinTech exhibition, FinTech Taipei; it received critical acclaims island-wide. With a participation of more than 200 institutions and startups from 11 countries, we welcomed more than 32,300 visitors at FinTech Taipei 2018. FinTech Taipei is the first FinTech Expo in Taiwan, it showcases the latest innovations of financial technology and facilitates exchanging and cooperation among both local and international FinTech players.

In FinTech Taipei 2019, you can see a bigger scale with eight themes included: FinTech Expo, International FinTech Forum, AI x Financial Industry, CXO Talks, Meeting Unicorns, FinTech Talks for entrepreneurs, Main Pavilion, and Demo Shows / Startup Matchmaking. Among these, Meeting Unicorns and FinTech Talks are exclusive events this year. We are also very pleased to welcome startups from eleven countries/sectors including the US, UK, Australia, France, Poland, the Netherlands, Singapore, Philippines, Malaysia, Japan, Vietnam, Korea and Hong Kong. There is a total of 6 national pavilions, 3 accelerators areas and five unicorns participating in the Expo. Note that we have included a translation service this year.

Innovation is the key for the economic growth in Taiwan, and it pushes the industries to grow. In order to create a friendly environment for FinTech innovation, TFSR will keep on integrating resources in the financial sector. By holding a FinTech exhibition, it is our hope to establish a FinTech platform which brings more innovative FinTech ideas and creates even more international business opportunities. Welcome to FinTech Taipei 2019!

## Welcome Message

2019 is a powerful year for FinTech development. It can be seen that technology evolves continuously and is now being applied to the financial services field in a wider aspect. An example is that the regulatory sandbox has been opened for over a year, and the Financial Supervisory Commission (FSC) has approved 7 experiments. These experiments are as follows: completing online loan applications by telecom mobile identity authentication, using blockchain technology in domestic fund transfers, building a weak centralized common trading platform, making one-day fund subscriptions and redemptions, and using API techniques to link industries for serving one stop travel insurance applications. These experiments are focusing on the weakness of the current financial services, and some of them are considered as the first innovation in the world. In addition, the FSC has approved 3 internet-only bank licenses, and consumers can enjoy the service as soon as next year. Will internet-only banks bring about changes to the Taiwanese financial sector? Will they be the showcase of financial technology applications? We are optimistic about this.

The flourishing growth of FinTech has been identified by sectors of the community. Last year, supervised by the Financial Supervisory Committee (FSC), the Taiwan Financial Services RoundTable (TFSR) and Taiwan Academy of Banking and Finance (TABF) co-hosted the first FinTech Taipei. More than 200 institutions from 11 countries, including the US, the UK, Australia, and Poland, making up more than 30,000 people visited the event over two days. Due to the enthusiastic responses we have received, we extended the scale of the event this year. We doubled the exhibition space, and more exhibitors will participate in the event. It shows various features of FinTech.

We hope that FinTech Taipei can bring us the following benefits: Firstly, the event is to be an integrative platform of cross-sector resources, and achieve the economies of scale. Secondly, we hope participants experience the true value of the services provided by financial technology that are based on the demands of consumers, FinTech for life will not be limited by written descriptions. In addition, the event represents the outcomes of FinTech development in Taiwan, and highlights the overall national innovation strength. Thanks for the kind support from all participants, and we wish FinTech Taipei 2019 a great success.

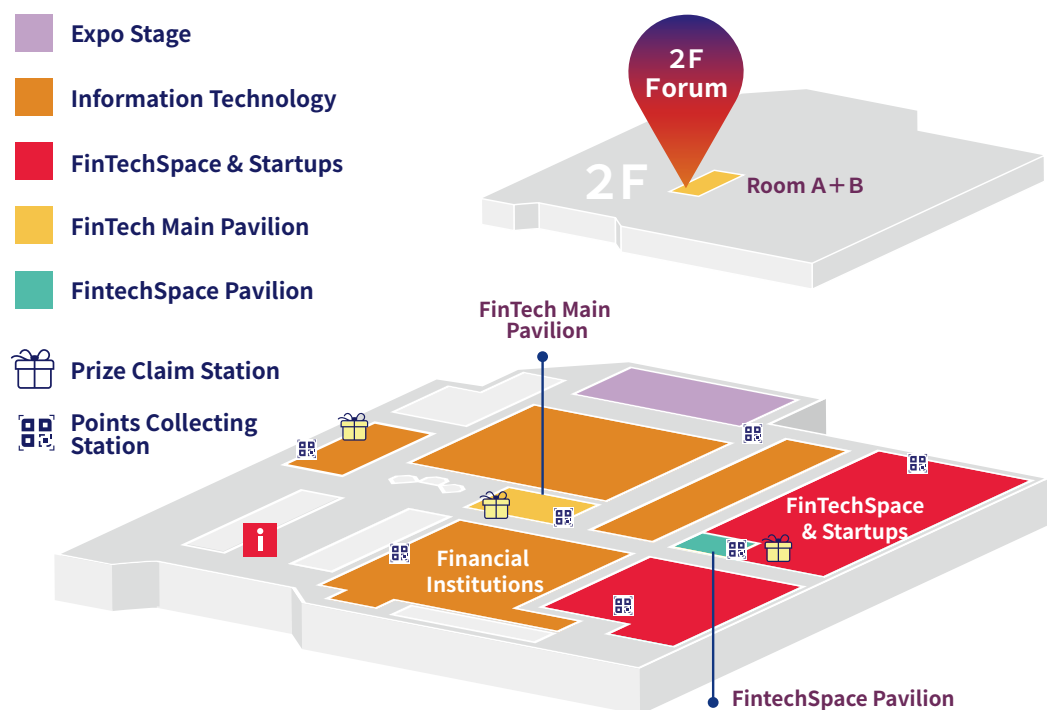
