1. New Foreign Futures Markets and Products Permitted for Brokerage Trading by Futures Commission Merchants

The Financial Supervisory Commission, in Public Announcement No. Financial-Supervisory-Securities-Futures-1070308692 of March 29, 2018, added the COMEX and its metals contracts to the list of futures exchanges and products that futures commission merchants are permitted to handle in their futures brokerage trading operations.

II. Market Wrap-up

As of the end of March 2018, the total number of TWSE listed companies stood at 914, an increase of 1 over the preceding month. Authorized capital was NT\$ 7,146.76 billion, an increase of NT\$ 3.49 billion over the preceding month. Market capitalization was NT\$ 32,748.48 billion, a increase over the preceding month of NT\$ 314.38 billion.

There were 752 TPEX listed companies, an increase of 2 over the preceding month. Authorized capital was NT\$ 727.88 billion, an increase of NT\$ 1.09 billion from the preceding month. Market capitalization was NT\$ 3,494.99 billion, an increase of NT\$ 158.55 billion from the preceding month.

The total value of stock trades on the centralized market was NT\$ 2,605.14 billion, an increase of NT\$ 954.10 billion from the preceding month. The volume of trading was 53.74 billion shares, an increase of 17.37 billion from the preceding month. The net value of inwardly remitted foreign funds was US\$ 211.319 billion, an increase of US\$ 0.658 billion from the preceding month.

There were a total of 65 securities firms. There were 15 enterprises exclusively engaged in futures commission merchant business, 39 securities investment trust enterprises, and 81 securities investment consulting enterprises.

截至 2018 年 3 月底止，上市公司計有 914 家，較上月增加 1 家；資本額新臺幣 71,467.6 億元，較上月增加新臺幣 34.9 億元；上市市值新臺幣 327,484.8 億元，較上月增加新臺幣 3,143.8 億元。

上櫃公司計有 752 家，較上月增加 2 家；資本額新臺幣 7,278.8 億元，較上月增加新臺幣 10.9 億元；上櫃市值新臺幣 34,949.9 億元，較上月增加新臺幣 1,585.5 億元。

集中市場股票總成交值新臺幣 26,051.4 億元，較上月增加新臺幣 9,541.0 億元；成交量 537.4 億股，較上月增加 173.7 億股。外資總累積匯入淨額 2,113.19 億美元，較上月增加 6.58 億美元。

專營證券商計 65 家，專營期貨商計 15 家，證券投資信託公司計 39 家，證券投資顧問公司計 81 家。
