1. **Limit on Quantity of Intraday Orders for Sale of Borrowed Shares Adjusted Back to Original Level (FSC Order No. Financial-Supervisory-Securities-Trading-1090362707 of 9 June 2020)**

In light of trends such as the gradual stabilization of domestic and international stock markets, the lifting of restrictions on short selling in most countries, Taiwan's successful efforts to control the COVID-19 pandemic, and the easing of uncertainties in international markets, the Financial Supervisory Commission (FSC) issued an order on 9 June 2020 adjusting the limit on the quantity of intraday orders to sell borrowed shares of a security from the "10 percent of the daily average trading volume of the security during the preceding 30 business days" that had been imposed from 19 March 2020 back to the original limit of 30 percent, effective from 10 June 2020.

II. Market Wrap-up

As of the end of June 2020, the total number of TWSE listed companies stood at 944 , an increase of 0 over the preceding month. Authorized capital was NT\$ 7,166.8 billion, an increase of NT\$ 0.6 billion over the preceding month. Market capitalization was NT\$ 35,382.7 billion, an increase of NT\$ 2,093 billion over the preceding month.

There were 776 TPEX listed companies, an increase of 0 over the preceding month. Authorized capital was NT\$ 746.1 billion, a decrease of NT\$ 0.5 billion from the preceding month. Market capitalization was NT\$ 3,723.8 billion, an increase of NT\$ 325.9 billion from the preceding month.

The total value of stock trades on the centralized market was NT\$ 3,677.8 billion, an

increase of NT\$ 342.3 billion from the preceding month. The volume of trading was 66.9 billion shares, an increase of 7.4 billion shares from the preceding month. The net value of inwardly remitted foreign funds was US\$ 200.734 billion, an increase of US\$ 4.135 billion from the preceding month.

There were a total of 62 securities firms. There were 15 enterprises exclusively engaged in futures commission merchant business, 39 securities investment trust companies, and 84 securities investment consulting companies.

壹、重要公告

一、調整回復每日盤中借券賣出委託數量。(中華民國 109 年 6 月 9 日金管證交字第 1090362707 號)

鑒於近期國內外股市逐步回穩，多數國家已取消限制放空措施，另我國疫情控制得宜，且國際市場不確定性因素亦趨於緩和，本會爰於 109 年 6 月 9 日發布令，調整每日盤中借券賣出委託數量，由原自 109 年 3 月 19 日起不超過該種有價證券前 30 個營業日之日平均成交數量之 10%，改為自 109 年 6 月 10 日起調整恢復為 30%。

貳、重要指標

截至 2020 年 6 月底止，上市公司計有 944 家，較上月增加 0 家；資本額新臺幣 71,668 億元，較上月增加新臺幣 6 億元；上市市值新臺幣 353,827 億元，較上月增加新臺幣 20,930 億元。

上櫃公司計有 776 家，較上月增加 0 家；資本額新臺幣 7,461 億元，較上月減少新臺幣 5 億元；上櫃市值新臺幣 37,238 億元，較上月增加新臺幣 3,259 億元。

集中市場股票總成交值新臺幣 36,778 億元，較上月增加新臺幣 3,423 億元；成交量 669 億股，較上月增加 74 億股。外資總累積匯入淨額 2,007.34 億美元，較上月增加 41.35 億美元。

專營證券商計 62 家，專營期貨商計 15 家，證券投資信託公司計 39 家，證券投資顧問公司計 84 家。
