| 中國輸入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。<br>The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms  | 該平台自開辦至 2025 年 <u>12 月底</u> 完成 <u>680</u> 案，貸款及保證金額新臺幣 <u>596.16</u> 億元。(其中新南向國家 <u>395</u> 案，貸款及保證金額新臺幣 <u>464.45</u> 億元)。<br>Since the launch of the platform, <u>680</u> applications for loans and guarantees of NTD <u>59.62</u> billion have been approved. Among them, <u>395</u> applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD <u>46.45</u> billion.  |

As of the end of <u>December</u> , it has approved NTD <u>32.06</u> billion dollars.   |

As of the end of <u>December</u> , it has approved NTD <u>3.53</u> billion dollars.   |

As of the end of <u>December</u> , the credit outstanding balance has increased NTD <u>179</u> billion to NTD <u>1,999</u> billion.   |

| 新南向國家公司來臺上市櫃相關統計<br>Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.  | 至 2025 年 <u>12 月底</u> 止，上市、上櫃及登錄興櫃之外國公司分別有 <u>89</u> 家、 <u>29</u> 家及 <u>5</u> 家，其中主要營運地在新南向國家之公司分別有 <u>15</u> 家、 <u>12</u> 家及 <u>0</u> 家。<br>As of the end of <u>December</u> , there are 89, 29, and 5 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 15, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively. |
