<p>中國輸出輸入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。</p> <p>The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms</p>	<p>該平台自開辦至 112 年 10 月底完成 502 案，貸款及保證金額新臺幣 394.85 億元。(其中新南向國家 285 案，貸款及保證金額新臺幣 319.2 億元)。</p> <p>Since the launch of the platform, 502 applications for loans and guarantees of NTD 39.49 billion have been approved. Among them, 285 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 31.92 billion.</p>

(The domestic banks have increased 2 branches as of the end of October.)</p>
<p>新南向國家來臺上市櫃相關統計</p> <p>Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.</p>	<p>至 112 年 10 月底止，上市、上櫃及登錄興櫃之外國公司分別有 78 家、29 家及 4 家，其中主要營運地在新南向國家之公司分別有 13 家、11 家及 0 家。</p> <p>As of the end of October, there are 78, 29, and 4 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 13, 11 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.</p>
