新南向政策主要工作計畫項目 Key work items	辦理進度—111 年 6 月底 Progress- as of the end of June, 2022
中國輸出入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。 The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms	該平台自開辦至 111 年 6 月底完成 407 案，貸款及保證金額新臺幣 312.11 億元。(其中新南向國家 233 案，貸款及保證金額新臺幣 251.68 億元)。 Since the launch of the platform, 407 applications for loans and guarantees of NTD 31.211 billion have been approved. Among them, 233 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 25.168 billion.
輸銀對新南向政策目標國家貸款核准額度年增率(含海外投資貸款、輸出融資及海外營建工程融資)：4.95%，並視實際情況滾動檢討。 Loans to domestic enterprises for use in relation to NSP target countries approved by EX-IM Bank (including loans for overseas investments, export loans and overseas construction project financing) growing at 4.95% YoY; subject to rolling review	111 年目標為核准新臺幣 253.43 億元。至 111 年 6 月底止核准 149.12 億元。 The EX-IM Bank aims to approve NTD 25.343 billion of the loans to NSP countries in 2022. As of the end of the month, it has approved NTD 14.912 billion dollars.
輸銀對新南向政策目標國家保證額度年增率：2%，並視實際情況滾動檢討。 Guarantee to domestic enterprises developing business in NSP countries approved by EX-IM Bank growing at 2% YoY.	111 年目標為新臺幣 36.33 億元。至 111 年 6 月底止為 36.24 億元。 The EX-IM Bank aims to approve NTD 3.633 billion of the guarantees to NSP countries in 2022. As of the end of the month, it has approved NTD 3.624 billion dollars.
輸出保險承保額度：按新南向政策目標國家之實際經濟情況，以承保金額較前一年度成長率 5%±2 個百分點為目標，並視實際情況滾動檢討。 Export insurance for goods sold to NSP countries approved by EX-IM Bank growing at 5%±2 percentage point YoY	111 年目標為新臺幣 278.78 億元。至 111 年 6 月底止為 189.55 億元。 The EX-IM Bank aims to approve NTD 27.878 billion of export insurance in 2022. As of the end of the month, it has approved NTD 18.955 billion.
本國銀行對新南向政策目標國家之授信總額成長，參酌東協十國經濟成長率，以成長率 5% 增減 2 個百分點為目標，並視實際情況滾動檢討。 Credit extended to firms in NSP countries growing at 5%±2 percentage point; subject to rolling review.	111 年目標為授信總餘額增加 370.77 億元(年底總餘額達 12,729.77 億元)。至 111 年 6 月底授信總餘額增加 1961 億元(累計月底總餘額為 14320 億元)。 The credit outstanding balance is expected to gain NTD 37.077 billion to NTD 1,272.977 billion by the end of 2022. As of the end of the month, the credit outstanding balance has gained NTD 196.1 billion to NTD 1432 billion.

協助國銀於新南向國家增設據點，每年核准本國銀行於新南向政策目標國家增設據點 3 家。 The FSC will help domestic banks expand their presences in NSP countries, approving at least 3 applications to set up presences in NSP countries every year.	111 年目標為 3 處；至 111 年 6 月底已核准 0 處。 As of the end of the month, the FSC has approved 0 applications.
新南向國家來臺上市櫃相關統計 Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.	111 年至 6 月止，上市、上櫃及登錄興櫃之外國公司分別有 76 家、31 家及 4 家，其中主要營運地在新南向國家之公司分別有 10 家、12 家及 0 家。 As of the end of the month, there are 76, 31, and 4 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 10, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.
