Among them, 344 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 39.22 billion.</p>

<p>新南向國家公司來臺上市櫃相關統計</p> <p>Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.</p>	<p>至 2025 年 2 月底止，上市、上櫃及登錄興櫃之外國公司分別有 85 家、28 家及 3 家，其中主要營運地在新南向國家之公司分別有 14 家、11 家及 0 家。</p> <p>As of the end of February, there are 85, 28, and 3 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 14, 11 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.</p>
