中國輸入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。 The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms	該平台自開辦至 2025 年 3 月底完成 <u>616</u> 案，貸款及保證金額新臺幣 <u>511.82</u> 億元。(其中新南向國家 <u>347</u> 案，貸款及保證金額新臺幣 <u>399.63</u> 億元)。 Since the launch of the platform, <u>616</u> applications for loans and guarantees of NTD <u>51.18</u> billion have been approved. Among them, <u>347</u> applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD <u>39.96</u> billion.

As of the end of <u>March</u> , it has approved NTD <u>7.46</u> billion dollars.

As of the end of <u>March</u> , it has approved NTD <u>0.54</u> billion dollars.

As of the end of March, it has approved NTD <u>11.09</u> billion.

As of the end of <u>March</u> , the credit outstanding balance has increased NTD <u>75.8</u> billion to NTD <u>1,896.2</u> billion.

新南向國家公司來臺上市櫃相關統計 Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.	至 2025 年 3 月底止，上市、上櫃及登錄興櫃之外國公司分別有 <u>88</u> 家、 <u>28</u> 家及 <u>2</u> 家，其中主要營運地在新南向國家之公司分別有 <u>15</u> 家、12 家及 0 家。 As of the end of March, there are 88, 28, and 2 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 15, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.
