Among them, 248 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 26.35 billion.</p>

Among them, 9, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.</p>
