II. Market Wrap-up

As of the end of October 2025, there were 1,055 TWSE-listed companies, an increase of 1 from the previous month. Their total paid-in capital amounted to NT\$7.88 trillion, a decrease of NT\$18.59 billion from the previous month, while the total market capitalization reached NT\$91.23 trillion, an increase of NT\$7.75 trillion compared with the previous month.

There were 860 TPEx-listed (OTC) companies, an increase of 5 from the previous month. Their total paid-in capital amounted to NT\$818.62 billion, an increase of NT\$1.98 billion from the previous month, and their total market capitalization reached NT\$6.98 trillion, an increase of NT\$91.14 billion compared with the previous month.

The total trading value in the centralized market amounted to NT\$10.06 trillion, an increase of NT\$561.67 billion from the previous month. The total trading volume was 94.68 billion shares, an increase of 1.34 billion shares compared with the previous month. The net value of inwardly remitted foreign funds reached US\$317.34 billion, an increase of US\$1.55 billion from the previous month.

There were 62 securities firms, 15 futures commission merchants, 37 securities investment trust companies, and 88 securities investment consulting companies.

截至 2025 年 10 月底止,上市公司計有 1,055 家,較上月增加 1 家;資本額新臺幣 7.88 兆元,較上月減少新臺幣 185.9 億元;上市市值新臺幣 91.23 兆元,較上月增加新臺幣 7.75 兆元。

上櫃公司計有860家,較上月增加5家;資本額新臺幣8,186.2 億元,較上月增加新臺幣19.8 億元;上櫃市值新臺幣6.98兆元,較上月增加新臺幣911.4億元。

集中市場股票總成交值新臺幣 10.06 兆元,較上月增加新臺幣 5,616.7 億元;成交量 946.8 億股,較上月增加 13.4 億股。外資總累積匯入淨額 3,173.43 億美元,較上月增加 15.53 億美元。
