Among them, 405 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 48.23 billion.</p>

Among them, 15, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.</p>
