中國輸出入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。 The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms	該平台自開辦至 2026 年 7 月底，完成 <u>730</u> 案，貸款及保證金額新臺幣 <u>700.15</u> 億元。(其中新南向國家 <u>434</u> 案，貸款及保證金額新臺幣 <u>548.46</u> 億元)。 Since the launch of the platform, <u>730</u> applications for loans and guarantees of NTD <u>70.02</u> billion have been approved. Among them, <u>434</u> applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD <u>54.85</u> billion.
輸銀對新南向政策目標國家貸款核准額度年增率(含海外投資貸款、輸出融資及海外營建工程融資)：4.95%，並視實際情況滾動檢討。 Loans to domestic enterprises for use in relation to NSP target countries approved by EX-IM Bank (including loans for overseas investments, export loans and overseas construction project financing) growing at 4.95% YonY; subject to rolling review	2026 年底目標核准新臺幣 308 億元。至 2026 年 7 月底止，核准 <u>254.39</u> 億元。 The EX-IM Bank aims to approve NTD 30.8 billion of the loans to NSP countries in 2026. As of the end of <u>July</u> , it has approved NTD <u>25.44</u> billion dollars. .
輸銀對新南向政策目標國家保證額度年增率：2%，並視實際情況滾動檢討。 Guarantee to domestic enterprises developing business in NSP countries approved by EX-IM Bank growing at 2%YonY.	2026 年目標為新臺幣 36.33 億元。至 2026 年 7 月底止，為 <u>19.76</u> 億元。 The EX-IM Bank aims to approve NTD 3.63 billion of the guarantees to NSP countries in 2026. As of the end of <u>July</u> , it has approved NTD <u>1.98</u> billion dollars.
輸出保險承保額度：按新南向政策目標國家之實際經濟情況，以承保金額較前一年度成長率 2 個百分點為目標，並視實際情況滾動檢討。 Export insurance for goods sold to NSP countries approved by EX-IM Bank growing at 2 percentage point YonY	2026 年目標為新臺幣 307.52 億元。至 2026 年 7 月底止為核准 <u>215.50</u> 億元。 The EX-IM Bank aims to approve NTD 30.75 billion of export insurance in 2026. As of the end of July, it has approved NTD <u>21.55</u> billion dollars.
本國銀行對新南向政策目標國家之授信總額成長，參酌東協十國經濟成長率，以成長率 5%增減 2 個百分點為目標，並視實際情況滾動檢討。 Credit extended to firms in NSP countries growing at 5%±2 percentage point; subject to rolling review.	2026 年目標為授信總餘額增加 800 億元，年底總餘額達 20,795 億元。2026 年 7 月底授信總餘額增加 <u>3,948 億元</u> ，累計授信總餘額為 <u>23,942 億元</u> 。 The credit outstanding balance is expected to gain NTD 80 billion dollars to NTD 2,079.5 billion by the end of 2026. As of the end of <u>July</u> , the credit outstanding balance has increased NTD <u>394.8 billion</u> to NTD <u>2,394.2 billion</u> .
輔導臺商運用國內資本市場籌措資金，證交所及櫃買中心赴新南向國家辦理 2 場次招商說明會，並拜會 8 家臺商企業，具體溝通有關回臺申請上市、上櫃或登錄興櫃之相關事宜。 To help Taiwanese firms in NSP countries tap the domestic capital market, TWSE and TPEX will arrange at least two investment briefings, and visit not less than 8 Taiwanese firms every year.	2026 年截至 7 月底，證交所與櫃買中心與新南向國家共辦理 <u>5</u> 場次招商說明會，並拜會 <u>48</u> 家臺商企業。 As of the end of <u>July</u> , TWSE and TPEX have arranged 5 investment briefings and visited 48 Taiwanese firms in NSP countries.
協助國銀於新南向國家增設據點，每年核准本國銀行於新南向政策目標國家增設據點 3 家。 The FSC will help domestic banks expand their presences in NSP countries, approving at least 3 applications to set up presences in NSP countries every year.	2026 年目標為 3 處；至 2026 年 7 月底，已核准 <u>2</u> 處。 As of the end of <u>July</u> , the FSC has approved 2 applications.
新南向國家公司來臺上市櫃相關統計 Statistics of the companies operating in NSP countries listed on Taiwan's stock market, OTC market and emerging stock market.	至 2026 年 7 月底止，上市、上櫃及登錄興櫃之外國公司分別有 <u>92</u> 家、 <u>30</u> 家及 <u>5</u> 家，其中主要營運地在新南向國家之公司分別有 <u>15</u> 家、 <u>12</u> 家及 <u>0</u> 家。 As of the end of <u>July</u> , there are 92, 30, and 5 foreign firms listed in Taiwan's stock market, OTC market and emerging stock market, respectively. Among them, 15, 12 and 0 firms operating in NSP countries are listed on Taiwan's stock market, OTC market and emerging stock market, respectively.
