| <p>中國輸出入銀行已建置「系統、整廠及工程產業輸出聯貸平台」，結合公民營銀行金融資源，提供廠商所需融資服務。 The EX-IM Bank has launched the Systems, Package Plant and Engineering Industry Export Syndicated Loan Platform which brings together resources of the privately-owned and state-owned banks to provide funding to firms</p> | <p>該平台自開辦至 2026 年 2 月底完成 688 案，貸款及保證金額新臺幣 609.36 億元。(其中新南向國家 401 案，貸款及保證金額新臺幣 475.89 億元)。 Since the launch of the platform, 688 applications for loans and guarantees of NTD 60.94 billion have been approved. Among them, 401 applications target New Southbound Policy (NSP) countries, with loans and guarantees of NTD 47.59 billion.</p> |
