- 1. FSC Issues Order Regarding Articles 23, 39, and 41-1 of the Standards Governing the Establishment of Securities Firms as well as Articles 18-1, 51, and 52 of the Regulations Governing Securities Firms

The Financial Supervisory Commission promulgated Order No. 1080360078 on 18 September 2019, stipulating that a securities firm applying for new businesses, establishing new branch, or investing in domestic or foreign enterprises shall fulfill the Information Security Self-Assessment Form, which is now the required application document.

#### II. Market Wrap-up

As of the end of September 2019, the total number of TWSE listed companies stood at 936, an increase of 4 over the preceding month. Authorized capital was NT\$7,149.14 billion, a decrease of NT\$290 million from the preceding month. Market capitalization was NT\$32,784.56 billion, an increase of NT\$667.36 billion over the preceding month.

There were 775 TPEx listed companies, an increase of 1 over the preceding month. Authorized capital was NT\$752.06 billion, a decrease of NT\$415 million from the preceding month. Market capitalization was NT\$3,223.94 billion, an increase of NT\$31.474 billion over the preceding month.

The total value of stock trades on the centralized market was NT\$2,081.13 billion, a decrease of NT\$309.76 billion from the preceding month. The volume of trading was 41.79 billion shares, a decrease of 7.14 billion from the preceding month. The net value of inwardly remitted foreign funds was US\$202.533 billion, an increase of US\$2.986 billion over the preceding month.

There were a total of 63 securities firms. There were 15 enterprises exclusively

engaged in futures commission merchant business, 39 securities investment trust companies, and 83 securities investment consulting companies.

本會於 108 年 9 月 18 日訂定金管證券字第 1080360078 號令,規定證券商申請 增加業務種類、增加營業項目、設置分支機構及轉投資國內外事業等事項,申 請書件應包括「證券商申請增加業務種類、增加營業項目、設置分支機構及轉 投資國內外事業資訊安全自評表」。

截至 2019 年 9 月底止,上市公司計有 936 家,較上月增加 4 家;資本額新臺 幣 71,491.4 億元,較上月減少新臺幣 2.9 億元;上市市值新臺幣 327,845.6 億元, 較上月增加新臺幣 6673.6 億元。

上櫃公司計有 775 家,較上月增加 1 家;資本額新臺幣 7,520.6 億元,較上月 減少新臺幣 4.15 億元;上櫃市值新臺幣 32,239.4 億元,較上月增加新臺幣 314.74 億元。

集中市場股票總成交值新臺幣 20,811.3 億元,較上月減少新臺幣 3,097.6 億 元;成交量 417.9 億股,較上月減少 71.4 億股。外資總累積匯入淨額 2,025.33 億美 元,較上月增加 29.86 億美元。

專營證券商計 63 家,專營期貨商計 15 家,證券投資信託公司計 39 家,證券 投資顧問公司計 83 家。
