II. Market Wrap-up

As of the end of November 2019, the total number of TWSE listed companies stood at 937, one more than the preceding month. Authorized capital was NT\$7,146.42 billion, a decrease of NT\$1.29 billion from the preceding month. Market capitalization was NT\$34,809.14 billion, an increase of NT\$420.55 billion over the preceding month.

There were 775 TPEX listed companies, a decrease of 1 from the preceding month. Authorized capital was NT\$749.89 billion, an increase of NT\$1.12 billion over the preceding month. Market capitalization was NT\$3,337.77 billion, an increase of NT\$11.06 billion over the preceding month.

The total value of stock trades on the centralized market was NT\$2,569.82 billion, a decrease of NT\$11.34 billion from the preceding month. The volume of trading was 47.54 billion shares, an increase of 3.22 billion over the preceding month. The net value of inwardly remitted foreign funds was US\$209.762 billion, an increase of US\$2.948 billion over the preceding month.

There were a total of 63 securities firms, 15 enterprises exclusively engaged in futures commission merchant business, 39 securities investment trust companies, and 84 securities investment consulting companies.

截至 2019 年 11 月底止，上市公司計有 937 家，較上月增加 1 家；資本額新臺幣 71,464.2 億元，較上月減少新臺幣 12.9 億元；上市市值新臺幣 348,091.4 億元，較上月增加新臺幣 4,205.5 億元。

上櫃公司計有 775 家，較上月減少 1 家；資本額新臺幣 7,498.9 億元，較上月增加新臺幣 11.2 億元；上櫃市值新臺幣 33,377.7 億元，較上月增加新臺幣 110.6 億元。

集中市場股票總成交值新臺幣 25,698.2 億元，較上月減少新臺幣 113.4 億元；成交量 475.4 億股，較上月增加 32.2 億股。外資總累積匯入淨額 2,097.62 億美元，較上月增加 29.48 億美元。

專營證券商計 63 家，專營期貨商計 15 家，證券投資信託公司計 39 家，證券投資顧問公司計 84 家。
