1. Broadened Range of Securities-Related Products that Funds of Funds May Trade

On 26 May 2020, the Financial Supervisory Commission addressed the need of Securities Investment Trust Enterprises to trade securities –related products via funds of funds by expanding the scope of securities-related products that such funds may trade. Funds of funds were already permitted to trade securities-related products derived from indices, and may now also trade government-bond futures and interest-rate swaps to increase investment efficiency.

II. Market Wrap-up

As of the end of May 2020, the total number of TWSE listed companies stood at 944, an increase of 1 over the preceding month. Authorized capital was NT\$7,166.2 billion, an increase of NT\$5.8 billion from the preceding month. Market capitalization was NT\$33,289.7 billion, a decrease of NT\$138.7 billion over the preceding month.

There were 776 TPEX listed companies, a decrease of 1 over the preceding month. Authorized capital was NT\$746.6 billion, a decrease of NT\$1.4 billion from the preceding month. Market capitalization was NT\$3,397.9 billion, an increase of NT\$214.3 billion over the preceding month.

The total value of stock trades on the centralized market was NT\$3,335.5 billion, an increase of NT\$317.2 billion over the preceding month. The volume of trading was 59.5 billion shares, a decrease of 700 million shares over the preceding month. The net value of inwardly remitted foreign funds was US\$196.599 billion, a decrease of US\$3,394 million over the preceding month.

There were a total of 62 securities firms. There were 15 enterprises exclusively

engaged in futures commission merchant business, 39 securities investment trust companies, and 84 securities investment consulting companies.

一、放寬組合型基金為增加投資效率從事證券相關商品交易範圍

為因應證券投資信託事業運用組合型基金從事證券相關商品交易需要，本會於 109 年 5 月 26 日放寬組合型基金為增加投資效率從事證券相關商品交易範圍，除原先得從事交易之衍生自指數之證券相關商品，將「公債期貨」及「利率交換」納入得從事交易之範圍。

貳、重要指標

截至 2020 年 5 月底止，上市公司計有 944 家，較上月增加 1 家；資本額新臺幣 71,662 億元，較上月增加新臺幣 58 億元；上市市值新臺幣 332,897 億元，較上月減少新臺幣 1,387 億元。

上櫃公司計有 776 家，較上月減少 1 家；資本額新臺幣 7,466 億元，較上月減少新臺幣 14 億元；上櫃市值新臺幣 33,979 億元，較上月增加新臺幣 2,143 億元。

集中市場股票總成交值新臺幣 33,355 億元，較上月增加新臺幣 3,172 億元；成交量 595 億股，較上月減少 7 億股。外資總累積匯入淨額 1,965.99 億美元，較上月減少 33.94 億美元。

專營證券商計 62 家，專營期貨商計 15 家，證券投資信託公司計 39 家，證券投資顧問公司計 84 家。
