II. Market Wrap-up

As of the end of July 2020, the total number of TWSE listed companies stood at 944, an increase of 0 over the preceding month. Authorized capital was NT\$ 7,187 billion, an increase of NT\$ 20.2 billion over the preceding month. Market capitalization was NT\$ 38,521.5 billion, an increase over the preceding month of NT\$ 3,138.8 billion.

There were 777 TPEx listed companies, an increase of 1 over the preceding month. Authorized capital was NT\$ 748.2 billion, an increase of NT\$ 2 billion from the preceding month. Market capitalization was NT\$ 3,808.7 billion, an increase of NT\$ 84.9 billion from the preceding month.

The total value of stock trades on the centralized market was NT\$ 4,941.2 billion, an increase of NT\$ 1,263.4 billion from the preceding month. The volume of trading was 83.3 billion shares, an increase of 16.4 billion from the preceding month. The net value of inwardly remitted foreign funds was US\$ 201.838 billion, an increase of US\$ 0.928 billion from the preceding month.

There were a total of 62 securities firms. There were 15 enterprises exclusively engaged in futures commission merchant business, 39 investment trust companies, and 85 investment consulting companies.

截至 2020 年 7 月底止,上市公司計有 944 家,較上月增加 0 家;資本額新臺幣 71,870 億元,較上月增加新臺幣 202 億元;上市市值新臺幣 385,215 億元,較上月增加新臺幣 31,388 億元。

上櫃公司計有777家,較上月增加1家;資本額新臺幣7,482億元,較上月增加新臺幣20億元;上櫃市值新臺幣38,087億元,較上月增加新臺幣849億元。

集中市場股票總成交值新臺幣 49,412 億元,較上月增加新臺幣 12,634 億元;成交量 833 億股,較上月增加 164 億股。外資總累積匯入淨額 2,018.38 億美元,較上月增加 9.28 億美元。
