I. Important Announcements (Chinese)

1. The FSC issues amendment to Article 23 of the Regulations Governing Securities Firms Accepting Orders to Trade Foreign Securities

To provide securities firms with more options for custodial institutions and to address the practical needs of these firms, the Financial Supervisory Commission (FSC) amended Article 23 of the "Regulations Governing Securities Firms Accepting Orders to Trade Foreign Securities" on 8 May 2024. This amendment allows securities firms accepting orders for trading of foreign securities to entrust the Taiwan Depository & Clearing Corporation with the custody of those securities. This change aims to increase the options available to securities firms and help enhance the security of investors' assets.

II. Market Wrap-up

As of the end of May 2024, the total number of TWSE-listed companies stood at 1,013, an increase of 7 over the preceding month. Authorized capital was NT\$ 7,670.73 billion, an increase of NT\$ 8.45 billion over the preceding month. Market capitalization was NT\$ 67,390.3 billion, an increase of NT\$ 2,525.89 billion over the preceding month. There were 822 TPEx-listed companies, an increase of 1 over the preceding month. Authorized capital was NT\$ 765.58 billion, an increase of NT\$ 1.92 billion over the preceding month. Market capitalization was NT\$ 6,381.76 billion, an increase of NT\$ 247.19 billion over the preceding month.

The total trading value in the centralized stock market was NT\$ 9,588.38 billion, an increase of NT\$ 1,262.8 billion over the preceding month. The trading volume was 113.31 billion shares, an increase of 18.96 billion over the preceding month. The net value of inwardly remitted foreign funds was US\$ 271.09 billion, an increase of US\$ 11.718 billion over the preceding month.

There were 59 securities firms, 15 futures commission merchants, 38 securities investment trust companies, and 88 securities investment consulting companies.

一、 修正「證券商受託買賣外國有價證券管理規則」第 23 條

為提供證券商多元保管機構選擇性,並考量證券商之實務需求,金管會於 113 年 5月8日修正發布「證券商受託買賣外國有價證券管理規則」第 23 條,開放證券 商辦理受託買賣外國有價證券業務得委由臺灣集中保管結算所股份有限公司保 管,以增加證券商之選擇性,並有助於提升投資人資產安全保障。

貳、重要指標

截至 2024 年 5 月底止,上市公司計有 1,013 家,較上月增加 7 家;資本額新臺幣 76,707.3 億元,較上月增加新臺幣 84.5 億元;上市市值新臺幣 673,903 億元,較上月增加新臺幣 25,258.9 億元。

上櫃公司計有822家,較上月增加1家;資本額新臺幣7,655.8億元,較上月增加新臺幣19.2億元;上櫃市值新臺幣63,817.6億元,較上月增加新臺幣2,471.9億元。

集中市場股票總成交值新臺幣 95,883.8 億元,較上月增加新臺幣 12,628 億元;成交量 1,133.1 億股,較上月增加 189.6 億股。外資總累積匯入淨額 2,710.9 億美元,較上月增加約 117.18 億美元。

專營證券商計 59 家,專營期貨商計 15 家,證券投資信託公司計 38 家,證券投資 顧問公司計 88 家。
