#### I. Important Announcements (Chinese)

### 1. Securities Firms Allowed to Lend Money for Subscriptions to New Shares

The Financial Supervisory Commission (FSC) has issued a partial amendment to the Regulations Governing Borrowing or Lending Money in Connection with Securities Business by Securities Firms through Order No. 1130384044 on 19 August 2024. Under the amendment, when an issuer issues new shares for cash following its initial listing on the TWSE or TPEx, a securities firm may accept financing applications from employees or existing shareholders of the issuer who wish to take loans from the securities firm for the purpose of subscribing to the newly issued shares, using the subscribed shares as collateral.

## II. Market Wrap-up

As of the end of August 2024, the total number of TWSE-listed companies stood at 1,020, an increase of 2 over the preceding month. Authorized capital was NT\$ 7,758.27 billion, an increase of NT\$ 44.36 billion over the preceding month. Market capitalization was NT\$ 71,086.04 billion, an increase of NT\$ 261.33 billion over the preceding month.

There were <u>826</u> TPEx-listed companies, an increase of <u>1</u> over the preceding month. Authorized capital was NT\$ <u>777.36</u> billion, an increase of NT\$ <u>4.86</u> billion over the preceding month. Market capitalization was NT\$ <u>6,860.04</u> billion, an increase of NT\$ <u>320.46</u> billion over the preceding month.

The total trading value in the centralized stock market was NT\$ 8,187.53 billion, a decrease of NT\$ 1,685.54 billion over the preceding month. The trading volume was 90.82 billion shares, a decrease of 17.58 billion over the preceding month. The net value of inwardly remitted foreign funds was US\$ 273.49 billion, an increase of US\$ 1.4 billion over the preceding month.

There were <u>64</u> securities firms, <u>15</u> futures commission merchants, <u>38</u> securities investment trust companies, and <u>88</u> securities investment consulting companies.

金管會已於 113 年 8 月 19 日以金管證券字第 1130384044 號令修正發布「證券商辦理證券業務借貸款項管理辦法」部分條文,增訂發行人初次上市櫃或上市櫃後現金發行新股時,證券商得接受發行人員工或原股東以認購股票為擔保,向證券商申辦資金融通之認股借貸業務。

## 貳、重要指標

截至 2024 年 8 月底止,上市公司計有 1,020 家,較上月增加 2 家;資本額新臺幣 77,582.7 億元,較上月增加新臺幣 443.6 億元;上市市值新臺幣 710,860.4 億元,較上月增加新臺幣 2,613.3 億元。

上櫃公司計有 <u>826</u>家,較上月增加 <u>1</u>家;資本額新臺幣 <u>7,773.6</u>億元,較上月增加新臺幣 <u>48.6</u>億元;上櫃市值新臺幣 <u>68,600.4</u>億元,較上月增加新臺幣 3,204.6 億元。

集中市場股票總成交值新臺幣 81,875.3 億元,較上月減少新臺幣 16,855.4 億元;成交量 908.2 億股,較上月減少 175.8 億股。外資總累積匯入淨額 2,734.87 億美元,較上月增加 14 億美元。
